

## **ELECTRONIC PUBLICATION AGREEMENT**

This agreement is made between NC State University on behalf of the on-line journal called Meridian (“Meridian”) and (“Contributor”).

### **RECITALS**

- A. Meridian electronically publishes and distributes materials in the field of education and technology.
- B. Contributor has submitted or will submit an article or other material to Meridian for publication (“Contribution”).

Now, therefore, the parties agree as follows:

1. Contributor has submitted or will submit Contribution in accordance with the Submission Procedures set forth on Exhibit A, “Meridian Author Guidelines.”
2. Contributor will retain copyright in the Contribution, subject to Meridian’s non-exclusive, royalty-free, fully paid up world-wide license to;
  - a. make a derivative work and reproduce, distribute, publish and transmit the Contribution (and “Contribution” includes any derivative work), through whatever medium Meridian determines is best to accomplish Meridian’s purposes, whether the medium is now known or later developed.
  - b. incorporate the Contribution into a compilation or into a multimedia, hypertext environment, including appropriate hyperlinks.
  - c. Contributor further grants to Meridian a perpetual world-wide, non-exclusive, royalty-free, fully paid up license for electronic publication and electronic distribution of the Contribution. This license is in consideration for publication of the Contribution by Meridian, and is granted by Contributor to Meridian at no charge.
3. Contributor warrants to Meridian that the Contribution has not been nor is it being considered for publication elsewhere.
4. Contributor warrants to Meridian that the Contribution is original material, except for such material from copyrighted sources as is reproduced with the written permission of the copyright holder sufficient to permit the Meridian to use the Contribution as set forth herein, and is in no way a violation of, or an infringement upon, any copyright belonging to any third party; that the materials contained in the Contribution are accurate; and that the Contribution contains no defamatory or otherwise illegal materials. The Contributor shall indemnify and hold Meridian, NC State University, and the Trustees, officers, employees, and agents of the University and Meridian harmless from any claims that the Contribution infringes a third party’s copyright or contains inaccurate, libelous or unlawful material, or otherwise violates any warranties or obligations of Contributor.

5. This Agreement, along with its attachments, constitutes the entire agreement between Meridian and the Contributor and supersedes any other understandings or terms. If the foregoing terms are satisfactory, please sign and date this Agreement; make one copy for your files and return the original to Meridian at:

6. Nothing herein constitutes a promise that the Contribution will be published. If the Contribution is not published by Meridian within 12 months of the date this agreement is signed, the license automatically terminates.
7. This agreement shall be governed and interpreted by North Carolina law, without regard to North Carolina's conflict of laws provisions, and any actions related to this contract, whether in tort or contract or otherwise, must be brought in Wake County, North Carolina.
